- Provide outreach, advocacy, and support to male survivors of violent crimes as well as engage other males in providing peer and mentor support and awareness on the role males can play in reducing and ending violence.
- Collaborate with the Elephant Club Coordinator with raising awareness and
  providing community outreach regarding domestic and sexual violence, teen and
  dating violence, human trafficking, child abuse, and other violent crimes and how
  these crimes impact boys and men as victims/survivors as well as how to provide
  support to boys and men to reduce their trauma as a result of violent crimes.
- Collaborate in partnership with Big Brothers Big Sisters of the Mississippi Valley. There will be a special focus on males who identify as LGBTQIA, African

American, and/or are involved in child welfare services due to these populations being under-served and/or having higher rates of victimization.
